Zajednička izjava: Evropa gasi detekciju seksualnog zlostavljanja djece online

Ovo, nažalost, nije prvoaprilska šala: Evropa isključuje detekciju seksualnog zlostavljanja djece na internetu

Od 3. aprila 2026. pružaoci online usluga u EU više neće moći otkrivati i uklanjati sadržaje seksualnog zlostavljanja djece na svojim platformama.

Mi, koalicija od preko 247 organizacija koje rade na unapređenju prava djece i okončanju seksualnog zlostavljanja, snažno osuđujemo neuspjeh donosilaca odluka u EU da produže pravni osnov koji je omogućavao ove aktivnosti detekcije.

Ovaj neuspjeh stvara duboko zabrinjavajući i neodgovoran jaz u zaštiti djece. Posljedice će biti razorne, u Evropi i šire. Kako bi se odgovorilo na milione slika i videosnimaka seksualnog zlostavljanja djece koji kruže internetom, detekcija u velikom obimu je neophodna i temeljna. Ona omogućava platformama da prijavljuju zlostavljanje organima za provođenje zakona, čime se pokreću istrage koje [omogućavaju identifikaciju žrtava i privođenje počinitelja pravdi](#). Također omogućava tehnološkim kompanijama da uklanjaju nezakonit materijal i spriječe njegovo ponovno dijeljenje. Zahvaljujući tim naporima, hiljade žrtava bivaju identificirane, a milioni zlostavljačkih datoteka uklonjeni iz optičaja.

Bez detekcije, broj prijava materijala seksualnog zlostavljanja djece drastično će opasti, kao što se vidjelo tokom [prethodnog prekida u pravnom okviru 2021. godine](#). Organi za provođenje zakona izgubit će ključne tragove za otkrivanje slučajeva seksualnog zlostavljanja, a djeca će ostati zarobljena u situacijama zlostavljanja. Istovremeno, zlostavljački sadržaj nastavit će se nekontrolisano širiti, prisiljavajući žrtve da iznova proživljavaju svoju traumu svaki put kada se taj sadržaj pogleda ili podijeli. Iza svake slike i svakog videosnimka nalazi se dijete, prisiljeno da trpi ponovljeno kršenje svojih temeljnih prava, uključujući i pravo na privatnost.

Zaštita djece nije opcija, to je obaveza utemeljena u okvirima Evropske unije i međunarodnim okvirima - neizbježna odgovornost. [Istraživanje za istraživanjem](#) pokazuje da građani EU dosljedno podržavaju mjere detekcije tokom posljednjih pet godina. Evropski lideri moraju odgovoriti na taj mandat. Djeca ne smiju nastaviti plaćati cijenu političkog zastoja.

Pozivamo donosiocje odluka u EU da hitno i odgovorno djeluju usvajanjem ambicioznog i trajnog pravnog okvira, bez odlaganja. Svaki dan bez detekcije još je jedan dan u kojem djeca ostaju nezaštićena. Evropska unija mora djelovati odmah kako bi zatvorila ovaj jaz, osigurala djelotvornu detekciju i ispunila svoju obavezu zaštite djece.
